Information on annual family income and race is required to determine eligibility for 2020 programs funded with Federal Community Development Block Grant (CDBG) funds. Each participant must determine the number of persons in their family, and then **CHECK THE BOX** that contains the amount of annual family income. **FAMILY INCOME** is defined as the total **Annual Gross** income of **ALL** family members living within the household. All sources of income must be counted from all family members residing in the household.
